

Notification of Works

Dear Resident,

We are currently undertaking engineering works in **Poole Rd** and **Goldsworth Rd** that may affect you. Contained in this leaflet you will find details of the where our works are being carried out, how they will alter in the coming weeks and how this will affect resident access to the area.

When:


 29^{th} September – 2^{nd} November, (D) to (G) – Pipes, HV, Comms

 2^{nd} November – 16^{th} November, (G) to (H) – Gas, Valves

 16^{th} November – 10^{th} December (C) to (A) – Pipes, Valves

Works:

From the 2nd November we will be excavating two sections in the Northbound carriageway of Goldsworth Rd. One is for final connection to the SGN Gas main, the second to install a branch and valve chamber.



From the 2nd November Goldsworth Rd will become Westbound only past this section for a period of two weeks, after which it will re-open in both directions. Church Street West will be northbound only with no entry via Forge End.


Entry to Poole Rd will continue to be via the Morrisons link road under temporary traffic lights.

From the 16th November Poole Rd South end will be blocked to traffic, but accessible from both ends, and Goldsworth Rd will be re-opened. Access to the Midas House carpark will be as before, via the carpark exit on Poole Rd, for a period of 4 weeks.

There will inevitably be some traffic disruption associated with this, for which we apologize in advance.



Vehicular access into carparks along this route will be maintained where necessary, but we would ask residents to park elsewhere where possible to facilitate any works being carried out across a carpark entrance/exit.

NOTE on the 9th, 11th and 13th of November several oversize loads will also be arriving into Poole Rd south entrance which may cause additional disruption.

Why are these works being carried out?

We are extending our district heating network to provide essential infrastructure for the Woking town centre. This is to deliver low-carbon environmentally sustainable energy supplies to Town Centre residents and businesses.



Disruption:

Vehicles – traffic access to Poole Rd will be affected, and bus routes will be diverted to avoid the works.

Construction/Delivery – Vehicles accessing sites will still have access via the Morrisons Link Rd




